### TRANSPORTATION PROVIDER

- B.. Small Transportation Provider—\$125 plus \$10 per vehicle**  
A public or not-for-profit agency providing transportation by operating 15 or fewer vehicles.
- C. Broker—\$200**  
A public or not-for-profit agency that arranges for the provision of individual transportation services.

### SUPPORTER

- D. Community Agency—\$125**  
A public or not-for-profit human service agency or other local community organization.
- E. National, State or Regional Organization—\$125**  
State and local transit associations; statewide public or not-for-profit organizations; federal, state and local governmental organizations; university/research organizations; Regional Planning Agencies/Councils of Governments, Metropolitan Planning Organizations.
