Connecticut Transportation Updates

Workshop Sessions A Success

On Tuesday, March 12, CACT presented the “Emergency Preparedness and Dispatcher Customer Service Workshop Sessions” at Greater Hartford Transit District. The event featured Brenda Clark, Supervisor Special Services/Training & Safety Outreach Services for Greater New Haven Transit District, who conducted the Dispatcher Customer Service Session. Brenda provided the attendees with a list of phrases that could be utilized by anyone who deals with the public (see sidebar on page 2.) Brenda noted that GNHTD offers an 8-hour Defensive Driving Course, broken into 2-4 hour sessions. For further information contact Brenda at 203-288-6282.

Dan Scace, CRCOG Urban Area Security Initiative Project Manager and Training Coordinator gave an overview of the Citizen Preparedness website: www.getreadycapitolregion.org and how to properly prepare for an emergency or disaster.

Bill Perkins, CRCOG Homeland Security Trainer and Planner and Project Coordinator for Region 3 Natural Hazards Mitigation Plan presented a comprehensive overview of Region 3’s Natural Hazards Mitigation Plan and noted the Incident Management Team consists of 56 members. The Regional Emergency Support Plan (RESP) supports communications and regional organizations when needed.
