New FTA Proposed Rule

The U.S. Department of Transportation's Federal Transit Administration (FTA) today announced a [Notice of Proposed Rulemaking \(PDF\)](#) that would improve the process for testing the safety and reliability of new transit buses funded with federal dollars. The proposed rule would establish minimum performance standards, a new pass-fail grading system for bus testing, and a weighted scoring process that would better assist local transit agencies in purchasing an appropriate vehicle.
