## A Successful Annual Legislative Breakfast

More than 110 people registered for the Wednesday, February 25, CACT and WTS Annual Legislative Breakfast at the State Capitol. WTS President Sandra Dumas welcomed everyone and thanked the various sponsors. The talk turned to tolls when two of the Transportation Committee members gave some brief comments. "The gas tax isn't going to cut it anymore", said Rep. Tony Guerrero, noting the fed's are more than willing to give out waivers (for installing tolls). Rep. Steinberg then said tolls are needed to support transit projects.

## LET'S GO CT!

Keynote speaker DOT Commissioner Jim Redeker stated "We need to plan for the future not just fix existing problems". Jim explained that the 18-month strategic planning process, TransformCT resulted in Governor Malloy's *Let's Go CT* which includes a 5- year Ramp Up Plan and a 30-year Vision plan. The plan includes a 25% expansion of bus service, integration of services, trail program, urban walkability, Port & Maritime creating a statewide Port Authority, investment in municipal and state roadways, bridges, traffic signals and supporting Transit Oriented Development.

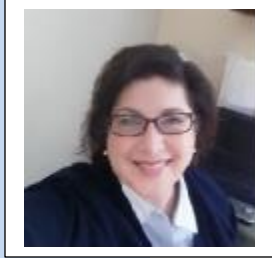
CACT Executive Director Mary Tomolonius gave a brief overview of bus operations, noting the importance of providing public transportation, the significant increase in ridership in 2014 and the need to maintain funding to support both the capital and operational projects.

**Michele Brooks**, Senior Associate, TransAction Associates, CTRTAP Program Manager

Michele Brooks is a Senior Associate at TransAction Associates, a provider of nationwide transportation solutions, specializing in developing public/private partnerships and implementing strategies to reduce demand on the roadways. She is currently responsible for the day-to-day management of the Connecticut Rural Transit Assistance Program. A Brandeis University graduate, she has worked for more than nineteen years in the field of Transportation Demand Management including serving as director of two Transportation Management Associations (TMAs), working with several Boards of Directors, conducting research projects, and providing training and education on transportation topics.

Michele has extensive experience in organizing large-scale transportation surveys and implementing on-site commuter programs that encourage employees to consider alternatives to driving alone. As a consultant to the 495/MetroWest Corridor Partnership, she conducted specialized briefings to MetroWest area legislators, town officials and local citizens on the proposed Regional Transit Authority, which was formed in 2008. Michele has also established the commuter benefits programs at a number of large employers and worked with the Town of Acton to institute a commuter rail service and Dial-a-Ride shuttle. Additionally, she worked with the Town of Acton and surrounding communities to develop the first Central Dispatch Call Center for Councils on Aging in Massachusetts.

Michele was part of the TransAction team that was hired by the Community Transportation Association of America (CTAA) to develop primers on Voucher and Emergency Ride Home Programs. The primers consisted of literature and on-line research, interviews with organizations that use vouchers or have ERH programs, conference calls with an expert panels, and preparation of best practices primers. Michele has mentored several other TransAction employees who currently manage Commuter Services Programs at 29 worksites that reach thousands of employees.

## APTA Conference Provides Valuable Information

APTA held its Annual CEO Conference February 7-10, 2015 in Phoenix, Arizona. More than 140 public transportation professionals gathered to engage in a highly interactive four day event focusing on industry challenges, sharing success stories and innovative ideas as well as building strong networking relationships.

Therese W. McMillan, Acting FTA Administrator, kicked off the conference with a discussion on aging infrastructure, growing service demand, workforce development and the critical need for a long term federal reauthorization bill.

Session topics included governance strategies for working with your Board of Directors, economic development benefits associated with transit projects, forward thinking management practices, building a stellar executive team and labor relation trends. Other sessions addressed asset and safety management, developing dynamic career pathways for front-line workforce staff and evolving American lifestyles that affect the success of Transit Oriented Development communities.

Attendance by CEOs and Deputy CEOs from across the country resulted in a highly successful event filled with collegial conversation, sharing common issues and exchanging ideas for solutions. The APTA Legislative Conference is scheduled for March 8-10, 2015 in Washington, DC. – *Kim Dunham, GNHTD*
