Transit Public Hearings

The Connecticut Public Transportation Commission (CPTC) is holding a series of public hearings around the state for transit supporters and advocates to voice their opinions on transit needs and services in the state. Following the public hearings, the CPTC will outline their recommendations (as they do every year) to the General Assembly's Transportation Committee, the Governor and the DOT Commissioner.

The hearings will be held at 7:00 pm on Sept. 9, Derby Town Hall; Sept. 30, Old Saybrook Town Hall; Oct. 6, Windsor Locks Town Hall and Oct. 13, Stamford Town Hall.
